Release and Waiver of Liability, Assumption Of Risk, and Indemnity Agreement ("Agreement"):

In consideration of participating in class activities I, the minor's (the student as identified on this form) parent and/or legal guardian, represent that I understand the nature of this Activity and that the participant is in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, participant will immediately discontinue participation in the Activity. I fully understand that this activity could involve accidental risks of bodily injury, including permanent disability, paralysis and death, which may be caused by participants own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility of losses, cost, and damages I incur as a result of participants participation in the Activity. I hereby release, discharge, and covenant not to sue Final Act Drama, LLC, its Respective administrators, directors, agents, officers, volunteers, and employees, other participants, and sponsors, advertisers, and , if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, claims, demands, losses, or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations and future agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save and hold harmless each of the Releasees from any loss, liability, damage, or cost, which any may incur as the result of such claim.
